#### Healthcare

- Support and encourage establishment of initiatives to cultivate and nurture healthy behaviors and attitudes at work and home
- Seek healthcare solutions to maximize local value, resisting attempts to burden employers with mandated benefits
- Support increased of the Graduate Medical Education funding for existing and new residency programs, and the protection of funding for trauma care facilities



#### **Economic/Community Development**

- Support continuati9on of the Texas Enterprise Fund, Texas Enterprise Zone Fund and the tax incentives available under the Texas Economic Development Act under Chapter 312 and 313

- Support the Research and Development Tax Credit
- Support creation and continuation of public sector initiatives to enhance business expansion
- · Support local government efforts to seek federal grants to enhance the quality of place
- Support improvement and expansion of Bell County venues for the attraction of events, conventions, and activities that draw visitors and increases the use of business services

- Support funding based on average daily enrollment only if the State increases funding to schools
- Support the reduction of time and resources spent on high-stakes testing and deemphasizing the utilization of standardized testing as the primary means for measuring student achievement, educator effectiveness or school performance
- Support legislation to provide incentives to encourage business participation in education and workforce development initiatives
- Support incentives that reward the collaboration of high schools with community colleges and universities to expand dual credit opportunities

#### **Energy/Water**


- Support legislation that protects the rights of Central Texas to maintain control of historical water rights

## **Guiding Principles**

Public Policy influences business success, workforce development, economic growth and quality of place. The Temple Chamber of Commerce engages in advocacy in support of the business community by engaging, advocating, and promoting initiatives, partnerships and public policy positions to preserve, protect and promote a business-friendly environment free of obstacles to growth and development. The Temple Chamber of Commerce believes a stronger local economy is only possible with a growing and strengthening business base.

The international crisis that impacted all in early 2020 is far from over. It is important to understand the budgetary impact at all levels of government is unprecedented as we seek greater assistance to support our local communities' response to the pandemic, and the need to infuse further relief for struggling small businesses, the backbone of the American economy. Pandemic Relief will be of greatest interest and likewise should gain the highest level of attention by public legislative leaders.

#### **Guiding Principles**

The Temple Chamber of Commerce Board of Directors adopted the following Guiding Principles to sharpen and expedite public policy action. The Public Policy Council may act on legislative and regulatory issues consistent with the following:

- Promotion and enhancement of the region's key economic sectors including health care, military/defense, hospitality, manufacturing, real estate, construction, retail, knowledge based and service industries
- Flexibility in healthcare related benefits for employers; access to quality and efficient healthcare that also promotes wellness; encouraging personal responsibility and accountability to help avoid unnecessary healthcare costs
- Comprehensively planned, constructed, and well-maintained infrastructure as a key to long-term economic development
- Embracing the fundamentals of the Free Enterprise System
- Collaborative, cost-effective solutions to regional infrastructure challenges
- Economic development initiatives which enhance the competitiveness of new and existing businesses
- Public education system to prepare all students to be successful in the workplace or in post-secondary education; creative, equitable and adequate funding methods to ensure that our region's public-school systems and high education institutions can continue to excel
- Initiatives to enhance the areas skilled workforce; enhance lifelong educational opportunities
- Equity in tax and fee structures, regulations and administrative procedures that produce positive economic growth and opportunity in the region
- Privatization and consolidation of services throughout the region when these actions are in the best interest of the public and economic growth of the area
- High quality, cost-effective government services offered in a manner conducive to the growth of competitive businesses
- Promotion of a sustainable expansion of the Central Texas military and defense industry
- Encourage business-minded individuals, knowledgeable of the community's vision and needs, to seek election to public office
- Equal opportunity for all citizens
- Reasonable actions to protect and conserve the environment

#### **Business Advocacy**

- Support the fundamental principles of the Free Enterprise System
- Oppose burdensome legislation and regulations imposed upon business
- Support equal opportunity for all citizens including pay quality
- Support the notion that the best decision is made closest to the point where the decision is to be implemented. Therefore, we support retaining local control



#### Transportation

- Maintain partnership with Texas Department of Transportation to disucss all transportation matters impacting the area
- Stay engaged in the initiative to expand I-14, The Gulf Coast Strategic Highway, from I-35 utilizing existing US 190 through Temple and east to Milam County
- Advocate growth opportunities at Draughon-Miller Temple Regional Airport
- Support continued funding and development of enhanced and expanded rail service and infrastructure through Temple
- Support improved highways, port of entry and other infrastructures that improve the safe, effective and efficient flow of products, goods, services and people, promote tourism and increase public safety funding



#### **Public Finance and Tax Policy**

- Use of "rainy-day" funds to support pandemic recovery including small business relief and community response
- Support the continued effort to develop a fair, equitable and transparent system for the administration and assessment of property taxes
- Support efforts to analyze local government expenditures to ensure sound and efficient use of public funds
- Support local government control to determine and establish the revenue and expense requirements without the imposition of an unrealistic, more restrictive "one-size" fits all revenue cap
- Support increasing the relief and elimination of the franchise (margin) fee upon business
- On matters related to online sales, support sales tax disbursement at point of delivery
- Oppose unfunded mandates and eliminate the practice of shifting the burden of financing programs to other layers of government or the private sector



#### National Security & Defense

- Work with the Heart of Texas Defense Alliance to enhance the armed forces presence in Central Texas
- Support continued enhancement and expansion of the Texas Army National Guard in Temple
- Support the continued funding for the Defence Economic Adjustment Assistance Grant (DEAAG) program at the \$30 million level or higher
- Support licensing reciprocity for those transitioning out of the military and military family members
